Immigration Talking Points

The next election has have taken on an urgency we haven't experienced in recent memory. This is truly a "whose side are you on?" moment.

We have a president who ran as a populist but is governing as an elitist. Unions are under attack. Instead of bring the country together, the Trump administration and its allies have spent more than a year undermining our democratic norms and pushing an agenda for the rich—from ripping healthcare away from millions to his new tax law that gives 83 percent of the benefits to the top 1 percent.

The Facts:

- Trump's harsh immigration policies are some of the most extreme, targeting immigrant youth, Dreamers, individuals eligible for Deferred Action for Childhood Arrivals or temporary protected status, and refugee families, through an immigration enforcement-only approach and discriminatory executive orders.
- The Trump administration's zero tolerance policies and executive orders on immigration and refugees are directly opposed to the AFT's historical positions on these issues. We oppose these orders, the racist and xenophobic logic that underlies them, the havoc they have created in the lives of those affected, and the damage they have done to America's standing in the world and to our national security.
- Facts on this issue:
 - The administration terminated the DACA program, leaving 800,000 undocumented immigrant youth at risk of deportation. Large-scale work-site raids similar to the ones that took place in California, Ohio and Tennessee have devastated communities. In Tennessee, more than 500 children missed school the day following a raid.
 - The Trump administration has terminated temporary protected status for more than 300,000 immigrants from Haiti, El Salvador, Honduras, Nepal, Sudan and other countries, many of whom have lived in the United States for over 20 years.
 - The Trump administration's zero tolerance policies are ripping children from their parents' arms and placing them in detention centers. In the first six weeks the program was implemented, 2,000 children were separated from their families. These policies are typical of tyrannical and dictatorial regimes, not democracies.
 - The AFT is working with community partners for a permanent fix for DACA and the more than 20,000 DACA-eligible bilingual teachers who are filling critical teacher
